## GENERAL PRICE LIST

These prices are effective as of July 1, 2019, but are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### **Basic Services of Funeral Director and Staff..... \$ 1,170.00**

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to the initial request for service, 24 hours per day, 365 days per year; arrangement conference with the family or responsible party; coordination of the service; preparation and filing of necessary permits; recording of vital statistics; preparation and placement of obituary notices; and staff assistance prior to, during and following the funeral including coordination with those providing other portions of the funeral (i.e. cemetery, crematory and others). Also included in this charge are overhead expenses related to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

### **Embalming..... 595.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### **Other Preparation of the Body**

- A. Dressing, casketing and/or cosmetizing of deceased..... 180.00
- B. Bathing and disinfecting remains without embalming..... 100.00
- C. Special care of autopsied remains/organ donation remains..... 200.00
- D. Re-constructive restoration when necessary (per hour)..... 100.00
- E. Hair dresser..... 50.00

### **Additional Staff Services**

- A. Visitation at Other Facility
  - Our services will include local transportation of encased remains, visitation setup, placement of encased remains, and supervision and attendance during visitation.
  - One day visitation (2 hour maximum)..... 400.00
  - Each additional hour of visitation..... 100.00
- B. Funeral Service at Other Facility (includes 1 hour visitation prior to service)..... 400.00
  - Our services include coordinating the funeral arrangement, supervision of committal or other disposition service, and equipment and additional staff necessary to conduct funeral at other facility.
- C. Memorial Service at Other Facility..... 400.00
  - Our services include coordinating the memorial service, supervision of the memorial service, and additional staff necessary to conduct memorial service at other facility.
- D. Graveside Service..... 400.00
  - Our service includes coordinating the funeral arrangement at graveside, supervision of the graveside service, and equipment and staff necessary to conduct the graveside service.

**Transportation:** All transportation charges are for within Davidson County. Additional mileage will be charged at \$2.00 per mile.

- A. Transfer of deceased from place of death to our facility..... \$ 150.00  
(Extra person on transfer of remains to our facility is \$75.00)
- B. Funeral Coach (Hearse)..... 300.00
- C. Funeral Coach (Van)..... 125.00

**Forwarding Remains to Another Facility..... 1,635.00**

This charge includes removal of remains, basic services of funeral director and staff, necessary authorizations, embalming, local transportation and air tray or combo unit. It does not include the service of staff or the use of facilities for any visitation or ceremonies prior to forwarding of the body, shipping charges or casket (if selected by family).

**Receiving Remains from Another Facility..... \$ 1,085.00**

This charge includes basic services of funeral director and staff, transportation from airport and transportation to cemetery or crematory (within Davidson County). It does not include the service of staff or the use of facilities for any visitation or ceremonies.

**Immediate Burial..... \$1,995 to 4,690**

This charge includes transfer of remains to funeral home, basic services of funeral director and staff in filing necessary documents and local transportation to the cemetery (within Davidson County). It does not include services of the staff or use of facilities for any visitation or ceremony.

- A. Immediate burial with casket provided by purchaser..... 1,995.00  
(All such containers must meet any applicable state or cemetery requirements.)
- B. Immediate burial with 20ga non-gasketed casket selected from our facility..... 2,790.00
- C. Immediate burial with casket selected from our facility ..... 1,995.00  
(in addition to cost of casket)

**Direct Cremation..... \$ 995 to 3,690**

This charge for a direct cremation includes removal of remains, processing forms and permits required by the State of Tennessee and crematory fees. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation. If you would like to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials (with or without and outside covering). The containers we provide are corrugated cardboard boxes.

- B. Direct cremation with cardboard container selected from our facility..... 1,095.00
- C. Direct cremation with Transporter..... 1,250.00
- D. Direct cremation with casket selected from our facility (in addition to cost of casket)... 995.00
